

CHAOS V-Ray Jumpstart TERMS & CONDITIONS

Chaos Software GmbH or any of its affiliated companies, (“**we**”, “**Chaos**” or “**Company**”), may at times offer you (“**you**”) the opportunity to participate in a free online course (“**Program**”) offered on its web site located at <https://www.chaos.com> (the “**Platform**”).

IF YOU FAIL TO COMPLY WITH THE FOLLOWING TERMS, AT OUR SOLE DISCRETION, YOU WILL FORFEIT REWARDS OTHERWISE EARNED DURING ANY PERIOD OF NON-COMPLIANCE AND WE MAY, AT OUR SOLE DISCRETION TERMINATE THIS AGREEMENT WITH IMMEDIATE EFFECT.

PLEASE NOTE THAT THESE TERMS ARE SUBJECT TO CHANGE BY CHAOS IN ITS SOLE DISCRETION AT ANY TIME. When changes are made, we will make a new copy of the Terms and Conditions available on the Platform. We will request that you assent to the updated terms, provided that if you do not assent to the updated terms, then you may decline and your participation in the Program will terminate immediately. Otherwise, your continued active participation in the Program constitutes your acceptance of such change(s).

1. By participating in the Program, you are bound by these Terms and Conditions (“**Terms**”) and indicate your agreement to them. All of the Company’s decisions are final and binding.
2. The personal information collected, processed and used as part of the Program will be used in accordance with Chaos’ Privacy Policy, which is available for your review at <https://www.chaos.com/privacy>.
3. This Program is void where such programs are prohibited. If you are under 18 years old or the age of majority in your jurisdiction, then you may not participate in the Program.
